

#### **Digital Track**

#### **On-Campus Track**

## **Admission Requirements**

In order to enroll in a bachelor's program at ISM, it is necessary to provide proof of a **general university entrance qualification**. Our degree programs do **not have a restricted admission based on a numerus clausus** (NC) system.

We **recognize equivalent prior knowledge** and credit the corresponding ECTS. Please contact our student advisory service. Each recognition is thoroughly assessed on an individual basis.

## **Job Options in Germany**

#### Students from non-EU States:

After graduation, you can apply for an 18-month residence permit to seek a job that matches your qualifications.

Once you have received a job offer that aligns with your qualifications, you will have the option to decide between applying for a German residence permit or an EU Blue Card for the subsequent phase of your stay.
